#### **Creating Pathways in the Panhandle**

In Amarillo, our team has been actively working with participants, focusing on key areas such as job placements, job shadowing, interviews, resume building, and parent meetings. We've continued collaborating with stakeholders to expand employment opportunities. TBE participants and their families have benefited from a variety of sessions, ranging from interview preparation for participants to parent discussions about available resources, planning, and roles and responsibilities.
